

## QUESTIONNAIRE FOR CANDIDATES AS DIRECTOR FOR CFHC

The COMMUNITY FIRST HEALTH CO-OP was incorporated under the Co-operative Association Act on Feb. 27/03 under Certificate #CP1035.

The purposes as stated in the Memorandum of Incorporation are:

"The COMMUNITY FIRST HEALTH CO-OP" provides a variety of health care services to individuals, families and communities. Its mandate is:

- a) To operate without purpose of gain for its members and to use any profits or gain to promote the purposes and activities of the co-op.
- b) To improve the efficiency and effectiveness of other registered charities and non-profit organizations by providing a facility, at below-market rates, to house the operations of other registered charities and non-profit organizations.
- c) To benefit the community through the promotion of health by carrying out activities such as operating a community wellness centre and providing various educational programs.
- d) To relieve poverty by providing housing for persons whose income is below the poverty line.

Through operating and/or supporting multi-level care facilities for seniors, including extended, assisted and supportive living complexes, primary care centers providing a multiplicity of health care services supported through professional practitioners, clinical practitioners, diagnostic practitioners, wellness programs, day care programs, home support programs including health promotion and education and acute care services in collaboration with existing providers, and such other activities to ensure quality care is available.

The co-op model is being employed because of the community participation it fosters. Decisions on our community's health and wellness care need to start at home. The principles of the Canada Health Act are considered a foundation for the on-going progress of this Association.
